Welcome to the Chappelle Gardens Residents Association! As a resident of Chappelle Gardens Residents Association, you are automatically a member of the Residents Association. The CGRA is a not-for-profit company, which is incorporated and professionally operated, managed, and maintained. This vibrant RA owns and operates, for the exclusive use of the members, the Social House facility and park, as well as various amenities and features within. In addition to supporting healthy living and enhanced quality of life, your RA creates opportunities to meet your neighbours and develop connections.

Membership in the Chappelle Gardens Residents Association is automatic and mandatory with the purchase of a home in Chappelle Gardens. The payment of dues, which is reviewed and established annually, is secured by an Encumbrance (subject to upward adjustment for inflation) registered on the title of each member's property. The Association is governed by a Board of Directors made up of Brookfield Residential and resident representatives.

Annual fees for 2026 are **\$434.09 plus GST**. *The Encumbrance amount for each property is \$350.00 per year and is subject to an annual adjustment by percentage increase, if any, of the Consumer Price Index (CPI) "All items" and GST.
